The following features are now available in [eFilePlus](#). This is in response to requests made by Faculty, Department Chairs and Academic Personnel staff in various units.

1. Continued viewing of snapshots once they leave the Chair's queue: Thus, the Chair will still be able to see the snapshot and could show it to (or print it for) any faculty member who wants reassurance that the Dean, CAP etc. is reviewing what they signed off on. The Snapshots presented in this way are read-only and can only be viewed, not changed in any way. Please share this information with your faculty.
